Net Tangible Asset Backing 31 July 2024

Diversified United Investment Limited (ASX: DUI) advises that the unaudited Net Tangible Asset backing of the Company's ordinary shares at 31 July 2024 was \$6.11 per share (30 June 2024: \$5.83).

The Net Tangible Asset backing calculation is based on investments at market value, is after tax on net realised gains, before any future tax benefit of net realised losses and before estimated tax on net unrealised gains/losses.

DUI is a long-term investor and does not intend disposing of its total portfolio. However, under current accounting standards the Company is required to provide for estimated tax on any net gains that would arise on such a theoretical disposal. After deducting this provision, the above figure would be \$4.99 (30 June 2024: \$4.79).

At 31 July 2024:

- International equities funds comprised 20.3% of the portfolio;
- Bank facilities were \$140M drawn as to \$77.5M;
- Cash and net short-term receivables were \$5.6M.
